- 21/22 – 01 Election of Chair**
Cllr Fratter proposed that Cllr Anderson be Chair and this was unanimously seconded. Cllr Fratter had been acting Chair up until this point and was thanked for his assistance
- 21/22 – 02 Apologies: To receive apologies and approve reasons for absence**
Apologies had been received from Cllr Warwick. They had also been received by Alison Carey but for technical reasons were not seen until after the meeting.

Steve Collins had previously indicated that he was stepping down (ref 20/21 083). He was thanked for his work on the Parish Council and his valued contribution to the village.
- 21/22 - 06 Reports from City and County Councillors**
Cllr Warwick's report had been circulated and is attached.
- 21/22 - 07 Report from Neighbourhood Watch**
Due to technical reasons this was received after the meeting.
Two notifications to villagers since the last meeting re Scams and Cold Callers
Advice has been given to a few villagers about how to deal with telephone cold calling.
The Police continue to patrol the village daily and Kerry will be holding a BEAT SURGERY in the village on Friday 2nd July. This will be advertised to villagers nearer the time.
- 21/22 - 08 Reports from Wardens and Representatives**
- a. Trees**
The contractor has consent to lift the tree crowns on either side of the burial ground path.
Winchester City Council has had an Ash on the border of the recreation ground pollarded
Overhanging branches on the border between the cricket pitch and Cricket Close are yet be addressed.
The Mountain Ash by the pond is doing well. **Action: Cllr Anderson**
 - b. Cricket**
The season is underway. The club is seeking a grant to help pay for the installation of nets, which would be situated parallel to the hedge on the left when looking from the carpark. The hard surface will be 30m in length and the nets 18m. The club would like to have a power outlet here in order that a bowling machine can be used.
The nets would be available for use by all parishioners.

The playground report had been circulated prior to the meeting and is attached. Funding will be needed in order to purchase new equipment and Councillors discussed possible avenues that may be explored. **Action: Chair**

- d. Pond**
Following the dredging Councillors are keen to purchase aquatic plants and are to seek guidance from a resident as to the best way to proceed. **Action: Chair**
- e. Burial and Memorial Ground**
The new path has been laid. This was possible because IGas kindly gave a grant for the work, for which the Parish Council is very grateful.
- f. Mowing**
The contractors have been asked not to mow certain areas where there are orchids and meadow saxifrage. The mowing schedules will be reviewed later in the year.
- g. Footpaths**
The Chair is to ask the landowner of an overgrown path if he is able to arrange for this to be cut soon, should it need cutting later in the year the lengthsman will be asked to carry out the work. **Action: Chair**
- h. Highways**
The gateways need to be stripped, primed and repainted, this will take place once the weather improves. It is likely that a new licence will be needed in order to erect a post on the opposite side of the road to the single gateway.
Further meetings need to be held with Highways to establish the positioning of the Duck Signs. **Action: Cllr Hall**
- i. Biodiversity**
Cllr Boucher's report was circulated prior to the meeting.
The Parish Council's response to the local plan has been submitted. The Parish Council is against building on greenfield sites. It was noted that the letter sent from the residents of Hacks Lane, who do not support the proposed SHELLA site nearby, to Winchester City Council will only count as one letter despite being signed by several residents.
