#### Pond

The pond warden sent a report', the 'overflow' from the road into the pond is clogged with mud. He will endeavour to unblock this within the next few days. # Report to Wonston & Micheldever Ward Parish Councils September 2025 from Cllrs Cunningham, Godfrey and Horrill

#### **Local Government Reorganisation**

Two periods of public consultation on the options for Local Government Reorganisation in the Hampshire & Solent area have been completed. Each of the 15 existing Councils will submit their preferred option to Government by the end of September, which we hope will reflect the responses from the public. There are two different proposals: one of 4 new unitary councils based around Basingstoke, Winchester, Southampton and Winchester and the other of 3 new unitaries that join Basingstoke and Winchester together plus larger Southampton and Portsmouth unitaries. Both proposals propose keeping a separate Council for the Isle of Wight.

The Government have set six criteria which the LGR proposals must satisfy:-

- 1. Achieve for the whole area the establishment of a single tier of local government
- 2. Be the right size to achieve efficiencies, improve capacity and withstand financial shocks
- 3. Prioritise the delivery of high quality and sustainable services
- Show Councils have worked together when coming to a view that meets local needs and is informed by Local views
- 5. Must support the devolution arrangements
- 6. Enable strong community engagement and deliver neighbourhood empowerment

The position regarding local elections in May 2026 is still to be confirmed. It is uncertain whether all out Hampshire County Council elections and a third of Winchester City Council seats will be contested. It is anticipated the new unitary shadow authorities will be up for election in May 2027.

Later in the year/early 2026 the Government will consult the public on the proposal selected by ministers from those submitted.

The Government will decide the final structure for local government in Hampshire, probably by the end of 2025. Do contact us if you want more details.

#### **Bin Collections**

Residents have received an update from the Council on the introduction of food waste from October 2025 alongside a new bin collection calendar up until September 2026. All households will receive a small grey kitchen caddy, with most also receiving a lockable outdoor bin, although blocks of flats may have a shared wheelie bin. The helpful leaflet also provides a useful reminder of the items which are acceptable for recycling and that small electrical items and batteries can also be recycled.

### **Local Plan**

The City Council still awaits the decision on the draft local plan from the Planning Inspector. The New Town decision for Micheldever Station (circa 20,000 houses) is still awaited, but we do know the Popham airfield proposal will be included in the Basingstoke and Deane Reg 18 plan which will be considered this Autumn.

Community Governance Review

The Council is proposing a governance review to make the Town Forum a Parish Council. This is seen as a positive move but the desire by the administration to expand the city area is causing concern especially from Littleton and Harestock Parish Council.

### **Twinning**

The City Council has endorsed a new twinning agreement between Winchester and Nizhyn in Ukraine. Nizhyn (pronounced 'Nee-jin') is a historic city located in the Chernihiv region along the Oster River. It has a population of around 72,000 and is home to over 300 historic buildings, 70 of which are of significant cultural and historic value. Its university, which was established in 1805, is one of the oldest in Ukraine.

Grants of up to £3000 are available for one-off pieces of expenditure on projects, equipment and other items which will help your organisation to do more, to reach more people, to provide better services or to try something different. ### Hampshire County Councillor Jan Warwick - September update

#### **Local Government Reform:**

Hampshire County Council has put forward a proposal for four unitary authorities, designed to balance financial resilience, service quality, and local identity. The suggested configuration includes a North and Mid Hampshire authority (covering areas like Winchester, Basingstoke and Deane, and East Hampshire), a South-West authority (including Southampton, Test Valley, and New Forest), a South-East authority (encompassing Portsmouth, Fareham, Gosport, and Havant), and the Isle of Wight as a standalone unitary.

This model is grounded in rigorous financial analysis and aims to protect vital services—particularly for our most vulnerable residents—while delivering long-term savings and stability. But it's important to acknowledge that this is not the only vision. Other councils have expressed concerns about scale, identity, and democratic accountability. Some fear that larger authorities may feel remote or disconnected from the communities they serve.

There is no single "right" answer. Each proposal has merit. Each reflects a different emphasis—whether on place, efficiency, or local voice. What matters most is that we approach this process with openness, respect, and a shared commitment to doing what's best for our residents.

The Government will decide the outcome, in March 2026.

- Remove keys when not in use
